Treasurer's Report: Rich Gordon

- 1. Explanation of charts in meeting packet.
- 2. Association dues will remain the same for 2024
- 3. Finances are healthy
- 4. Major expenses are plowing, sanding, water distribution, and road maintenance
- 5. Inflation has driven up costs
- 6. Questions regarding the April Storm and cost
- 7. Questions in regards to the Town's Modock Hill Plan to include cross sections at Highland/Brenner & Gotzens egress reconfigured and partial upgrade.

Water Report:

- 1. Well's 1-3: Well 4: All producing positive output:
- 2. Two water main breaks at Gotzens & Landsdown in August and September caused by heavy equipment by the Town of Conway.
- 3. State mandated monthly water testing drawn by LRW, and tested by eastern analytical. Results are all available on RMPOA.net.

- 4. Slightly elevated levels of Total coliform present mud fall. This happens from high usage and contaminated spigots. This triggers extra testing which came back normal.
- 5. Energy costs have decreased due to the precipitation increase.
- 6. Water usage is 3.6 million gallons over the past 12 months. Consistent with previous year
- 7. Discussion with home owners on how to lower energy cost by switching providers.

Road Report:

- 1. December winter rain storm caused fissures on Highland: Regent: The Spur.
- 2. Wet conditions have contributed to the delay of Modock Hill Road Project
- 3. Ditching on Arlberg Drive & the natural ditch on Brenner: Russ Lanoie/Burnham Company
- 4. The roads are built in a 50 foot Right of Way (approx. telephone pole to property stake). The home owners encroaching into the ROW to clear easement for plowing.
- 5. RESPONSIBILITY OF OWNER-To clear the culvert under their driveways for proper drainage.
- 6. DRIVEWAY PERMIT: Owner/Builder responsibility to acquire from Board before building a new driveway. This allows for a conversation with RMPOA road agent about drainage.
- 7. An abutter's friend asked about the new construction on Modock Hill Road.
- 8. An owner inquired on cost of materials by Town for upgrades.

Open Discussion:

- 1. Discussion around cars speeding. Speed bump was placed on Landsdown. Residents urged to contact Conway Police.
- 2. Board plans to replace all street signs in the coming months.
- 3. There will be 123 homes when all are complete. (2 new construction permits)
- 4. Question asked if contractors are responsible for road repairs after construction of new homes. David stated that board could use driveway permit to enforce this.
- 5. Discussion around drainage and berm at the intersection of Regent and Highlands.
- 6. Discussion around adding street signs, stop signs, speed limit signs, and stop ahead sign on Highlands before intersection of Modock Hill Road. Signs ordered.
- 7. Beach Rights: RMPOA has deeded beach rights to the 5 Eidelweiss beaches, Geneva, Boulder, Edelweiss, Pudding, and Thusis Roads.
- 8. RMPOA has no right at this time to install canoe/kayak racks at the beaches- those are for Eidelweiss property owners
- 9. STRs: To include all rentals short and long term. Public Safety Regulations (online)
- 10. The Town posted Public Notice on new Safety Regulations located on line: "Public Notices and Information"
- 11. The Generators at 1005 Modoc Road and 3 Highland Drive were serviced by Powers Guaranteed Services.

BPPP3 Association:

- 1. Comprised of owners around the ponds- along Allard Hill, Bottom of Brenner Drive, Island Drive.
- 2. BPPP received grant money to help mitigate sand and silt from running into ponds.
- 3. RMPOA and the Town of Conway are cooperating with BPPP.
- 4. RMPOA has not agreed to any financial obligations at this point but is supporting efforts.
